ORDER:

In the G.O. 1st read above, Government have issued orders declaring **24.09.2015 (Thursday)** as Holiday on the occasion of **Bakrid(Id-UI-Azha)** under Negotiable Instrument Act 1881.

2. In the letter 2nd read above, the Chief Executive Officer, Andhra Pradesh State Wakf Board, Hyderabad has requested to declare **25.09.2015 (Friday)** instead of **24.09.2015 (Thursday)** as Holiday on the occasion of **Bakrid(Id-UI-Azha)** as per moon sight.

The Government, after careful consideration of the matter, have decided to change the Holiday on the occasion of **Bakrid(Id-UI-Azha)** on **25.09.2015 (Friday)** instead of 24.09.2015 (Thursday) under the Explanation to Section 25 of the Negotiable Instruments Act, 1881 (Central Act XXVI of 1881). Accordingly, the following notification is issued and shall be published in the extra-ordinary Gazette of Andhra Pradesh State:
